### FY21 FIRE PROTECTION GRANT APPLICATION OPENING

Dear Fire Chief:

The New Mexico Fire Protection Grant Council will begin accepting applications for the FY21 grant cycle on Wednesday July 15, 2020. The web-application will be available on the PRC website at

Please read all the attachments carefully. Two levels of grants are available: Individual department grants; and County-wide project grants. All fire departments currently certified and funded by the New Mexico State Fire Marshal Office are eligible to apply. The attached Eligibility Requirements and Selection Criteria document outline specific requirements and restrictions.

The maximum award amounts remain unchanged. The amount awarded to a single applicant will not exceed \$200,000 for specific project types. The maximum award for all other justified critical needs will not exceed \$100,000. Matching funds requirements and selection criteria have been outlined in detail on the attached *Eligibility Requirements and Selection Criteria*.

Please note: Applications submitted without the signatures of the Fire Chief and the Fiscal Agent will not be considered. All applicants shall be NFIRS compliant. Applicants with delinquent NFIRS reports for the period of July 2019 to June 2020 at the time the application closes will not be considered.

The deadline to submit the application on the web-site is no later than midnight on Tuesday, September 15, 2020. A confirmation number will be issued at the time of submittal.

Any ISO Class 10 fire department that is awarded a grant and consequently loses its qualification for State Fire Funds per Title 10 Chapter 25 Part 10 of the NMAC will return the apparatus and equipment to the State Fire Marshal for redistribution.
