VI.	New Business 1. Discussion - National Volunteer Council: NM Board Creation – Jaime Gonzales and NFVC CEA Sarah Lee a. NFVC CEA Sarah Lee presented the history and purpose of the National Volunteer Fire Council. Ms. stated New Mexico is currently not part of their national board. She also discussed the benefits, available training, mental health assistance, and national awards. More information available at www.nvfc.org . Chair Perez asked Councilor Gonzales and State Fire Marshal Varela to provide on update on the possibility of New Mexico becoming part of the NVFC.

- 2. Discussion NM Firefighters Academy: Changes to NMAC Randy Varela/Austin Meuli
 - a. Interim Director Austin Meuli stated the Fire Academy is currently working on a firefighter skills task book aimed at new members to complete prior to attending a Firefighter I/II course in order to have them functional on a fire scene. Skills within the book would be department lead and signed off by a fire chief. He also stated the book follows current NFPA standards and will be updated as the standard updates.
 - b. State Fire Marshal Randy Varela stated they are planning to change the wording of the NMAC to fit the new skills task book along with the requirements for a firefighter to become certified through the Fire Academy. He also stated roofs will be replaced at the Fire Academy in Socorro this year, the burn building will be completed, all AV equipment in the academy classrooms have been updated and discussed the plans to develop a satellite academy in Santa Fe. Assistant Fire Marshal Anthony Leyba stated the second distribution fund will be released on February 15th and expressed his thanks for support from the council.
